# **SOUTHERN IRISH TERRIER SOCIETY RULES 2014**

1. The Club shall be called the Southern Irish Terrier Society, and its objects shall be to encourage the breeding and exhibition of Irish Terriers, to help beginners, to encourage selective breeding of Irish Terriers by its members, and to further in every way possible the interests of the breed.
2. The Club shall consist of a Patron, President, Vice President, Chairman, Vice Chairman, Hon. Secretary, Treasurer and a committee of a minimum of six and not more than 10 persons and an unlimited number of members.
3. The management of the Club shall be in the hands of the Officers of the Club and a committee of at least six, each of whom will retire annually. Members of the Committee shall be eligible for re-election every year and together with the Officers of the Club will have full voting rights.

Meetings of the Committee will be held at least twice a year, or as often as deemed necessary. A quorum for meetings shall be four Committee members of which at least one must be an Officer.

The Committee shall have the power to co-opt members onto the Committee in the event of positions becoming vacant between General Meetings. Co-opted members shall only hold office until the next General Meeting of the Club at which an election of Officers and Committee takes place. No individual who has been a member for less than one year may be elected onto the Committee.

4. Candidates for membership shall be accepted upon payment of one year's subscription.
5. Each member shall be entitled to one vote immediately upon acceptance of membership. In the case of joint memberships each member of the partnership shall have one vote. Postal or proxy votes will not be allowed. Voting for Officers and Committee at the A.G.M. shall be by a secret ballot. All other voting shall be by a show of hands.
6. The property of the Club shall be vested in the Committee. In the event of the Club ceasing to exist, a General Meeting shall be called to decide the

disposal of the Club's assets and the outcome of the meeting notified to the Kennel Club.

7. The following Banking Accounts shall be held on behalf of the Society at Lloyds Bank plc, North End Branch, BX1 1LT into which all revenues of the Society will be paid as appropriate:

- Main Account
- Deposit Account
- Rescue Account

Withdrawals shall only be made in the case of the Main and Deposit Accounts on the signatures of two of the following Officers: Chairperson; Treasurer and Hon Secretary.

In the case of the Rescue Account: either the Chairperson; Hon Secretary and The Rescue Coordinator.

8. The Annual Subscription shall be such amount as agreed by members in General Meeting and notified to the Kennel Club. No Member whose subscription is unpaid is entitled to any privileges of Membership and if the member shall fail to pay the outstanding subscription by the Annual General Meeting his/her name shall be automatically erased from the register. Acceptance back on to the register will be dependent upon a new application and payment of arrears.
9. Any member who shall be suspended under Kennel Club Rule A42i (4) and/or disqualified under Kennel Club Rule A42i (8) shall ipso facto cease to be a member of the Society for the duration of the suspension and/or disqualification.

If the conduct of any member shall, in the opinion of the Committee of the Society, be injurious or likely to be injurious to the character or interest of the Society may, at a meeting, the notice concerning which includes as an object the consideration of the conduct of a member, determine that a Special General Meeting of the Club shall be called for the purpose of passing a resolution to expel him/her. Notices of the Special General Meeting shall be sent to the accused member giving particulars of the complaint and advising the place, date and hour of the meeting that he/she may attend and offer explanation. If at the meeting a resolution to expel is passed by a two-thirds majority of the Members present and voting, his/her name shall be forthwith erased from the list of Members and he/she shall thereupon cease for all purposes to be a member of the Society, except that he/she may within two calendar months from the date of such meeting, appeal to the Kennel Club upon and subject to such conditions as the Kennel Club may impose.

10. The financial year of the Society shall be from 1<sup>st</sup> November to 31<sup>st</sup> October annually. The Annual General Meeting shall be held at the Members Limited Show.

11. At the Annual General Meeting, a report of the Committee and a Balance Sheet duly audited shall be received. Officers and Committee for the following year will be elected. No business shall be transacted unless notice thereof appears on the Agenda, with the exception of routine matters or those which in the opinion of the Chairperson of the meeting are urgent. Each member shall be entitled to one vote, with the Chairperson having the casting vote in the event of a tied decision.

Notice of the Annual General Meeting shall be inserted in the Schedule for the Members Limited Show and two months' notice given to members. Items for inclusion on the Agenda should reach the Hon. Secretary 42 days before the Annual General Meeting. The Agenda will be circulated at the meeting.

11a. A special General Meeting shall be summoned by the Hon. Secretary if 50% of the members send a signed requisition stating the subject to be discussed and requesting a Special General Meeting to do so. The Committee of the Society is also empowered to call a Special General Meeting. Notice of a Special General Meeting, giving its date, place, time and item(s) on the Agenda to be discussed, will be sent in writing to each member at least 4 weeks before the meeting is held.

12. The rules of the Society may not be altered except at a General Meeting, the Agenda for which contains specific proposals to amend the rules. Any proposed alteration to the Rules may not be brought into effect until the Kennel Club has been advised and has approved the alteration.

13. The Officers acknowledge that during the month of January each year, Maintenance of Title fee will be forwarded to the Kennel Club by the Secretary for continuance of registration and by 31<sup>st</sup> July each year other returns as stipulated in the Kennel Club Regulations for the registration and Maintenance of Title of Societies & Municipal Authorities, will be forwarded to the Kennel Club. The Officers will also acknowledge their duty to inform the Kennel Club of any change of Secretary of the Society which may occur during the year.

14. The Kennel Club shall be the final court of appeal in all matters of dispute.

15. The Society shall not join any Federation of Societies or Clubs.

16. The Society shall make a list of members and their addresses available for inspection if so requested by the members of the Society or by the Kennel Club.

17. The Society shall produce a list of Judges each year which must be submitted to the Kennel Club as part of the Society's Annual Return. The purpose of such lists is to indicate to interested parties those persons the Breed Society would support at differing levels of judging. Membership of the Society is not a pre-requisite for inclusion in the lists. Judges Lists should be divided in the following way – A1, A2, A3, B & C Lists. A must

indicate all persons the Society would support to award Kennel Club Challenge Certificates for the breed. List A3 must indicate Judges the Society would support to award Challenge Certificates having gained the necessary experience. List B must indicate all persons wishing to start judging and gain experience of the breed. List C must indicate all persons who show interest in the breed and to judge.

The Hon. Secretary shall be notified in writing of names of persons to be considered by the Committee for each of the Judging Lists. The required judging experience considered to be necessary/desirable for inclusion of a person's name on each list should include previous knowledge and handling of the breed wherever possible, an interest in promoting the aims and objects of the Society, and with FIVE years' experience of breeding and exhibiting dogs at all differing levels of Shows.

18. No person whilst an undischarged bankrupt, may serve on the Committee of, or hold any other office or appointment within a Kennel Club Registered Society.
19. Any member of the Committee absent from three consecutive meetings shall cease to be members of the Committee save in exceptional circumstance accepted by the Committee.

It was very windy outside so judging took place inside, pity it was blowing a gale as Irish Terriers on green grass look so much more attractive than on black rubber squares.

There was a little bit of swearing in LD otherwise we had a very peaceful day. Quality was not great in the lower dog classes & front movement throughout was a worry. There were some low set tails, also a tendency to level toplines instead of the correct, slight & gentle arch over the loin. A few were flying their ears but by & large ears were not a problem. Not a cracked pad in sight, temperaments of course were great. They make a superb family pet, medium sized, sporty & athletic. The breed has changed quite a lot since the Pathfinder & Breezy days but they have certainly retained their dare devil character & animated outlook on life. They must not be just a smart looking terrier – they must also have that unique graceful & racy outline which sets them apart from other terrier breeds. I really like them as a breed & it is obvious that they enjoy participation.

BIS was the dog, Zodiak Von Der Emsmuehle, all the way from Germany but Mr & Mrs Gruettner come over to our club shows on a regular basis & often walk away with top honours; BOS was Wyndam Rionach at Lakeridge & she was also the dam of the RDCC. Wyndam Nuala at Sonorra was a standout BP & Ch Montelle Mi'Lady, at 11½ is a great advert for the breed, still fit & able bodied with good eyes & teeth, lovely coat & colour.

### **MINNOR PUPPY DOG (1)**

1st Anderson's **KERRYKEEL RUARAI DH**, 7½ months, good length of head, well carried ears once he settled, well proportioned, but needs to drop in body & grow into himself. Bit loose in movement all round, tad close behind. Well handled.

### **PUPPY DOG (2)**

1st Stahle & Nichols' **CHANTELLE'S MICHAEL**. 10 months, attractive head & eye, needs a little more body, good reach of neck, moved OK behind but must improve in front to progress further.

2nd Bradley's **ROYAL EDITION AT MONTELLE**. 'asbo' of 9 months, excellent coat texture & body, good bone, legs & feet, keen expression but ears need to settle. Rather uncoordinated in movement, needs time & patience.

### **JUNIOR DOG (3)**

1st Veillet-Lavallee's **MONTELLE DESIGN IN GOLD**. Yearling, I did not care for his head & expression but has a decent outline, good coat, bone & feet. Moved better than 2 or 3;

### **NOVICE DOG (2)**

Eyecatching young dog in good form, fit & well-muscled, switched on showman who was interested in all around him, high spirited with good tailset & correct topline, well-fitting coat, masculine head, keen expression, well carried ears, good neckline, well placed shoulders, sound mover, showed himself off at all times. **DCC & BIS**

### DNA TESTING SCHEMES

DNA Testing schemes currently cover conditions that are either recessively or dominantly inherited.

For recessively inherited conditions, the DNA test determines whether a dog is clear (no copies of the mutant gene), a carrier (one copy of the mutant gene and one normal gene) or affected (two copies of the mutant gene).

For dominantly inherited conditions, the DNA test determines whether a dog is clear, having no copies of the defective gene or single affected, having one copy of the defective gene.

# THE ROAD TO COMPULSORY MICROCHIPPING

## **What does the law say?**

From 6 April 2016 all puppies in England must be microchipped by the time they are 8 weeks old, (prior to leaving the breeder) and registered with a microchip database that is compliant. Anyone who does not have their dog microchipped after 6 April 2016 could have a notice served and will have 21 days to have the dog microchipped, failure to do so may result in a fine of up to £500.

Where a dog is transferred to a new keeper, the new keeper must, unless the previous keeper had already done so, record their contact details on a government complaint microchip database. No keeper may transfer a dog to a new keeper until it has been microchipped, unless a certificate from a veterinary certificate has been issued regarding the dog's health.

## **Microchipping in other areas**

The Welsh and Scottish governments are working towards bringing in compulsory Microchipping in the spring of 2016, in line with England.

Full details need to be recorded on a compliant microchip database for the dog and the keeper. This includes the name and address of the keeper, and if the keeper is the breeder and has a local authority licence this will also need to be recorded.

Regarding implanting microchips, no person may implant a microchip unless they are a veterinary professional or if they have been on a government approved training course e.g. Lantra.

## **How do you check a rescue dog's microchip details?**

Breed rescues are now able to enter a microchip number on any one of the seven listed database websites including Petlog and the number will be checked with all seven databases.

If the number is valid and the microchip can be located, the status of the microchip, plus the name and contact details of the database is returned. Only the microchip number is checked and no personal data on the owner/keeper or animal is shared. Retrieval of information will still require a secure log-in from



an authorised account. Should a microchip number not be located on any of the databases, the database operator will try to determine which database it should be located on by premise of the manufacturer prefix number. This will ultimately make it easier for breed rescues when trying to locate a dog's owner.

### **How to choose an implanter?**

This new online service [www.findapetlogimplater.org.uk](http://www.findapetlogimplater.org.uk) will enable breed rescues to find their nearest implanter of Petlog associated microchips by simply entering their postcode and searching within a radius.

## **THE DANGEROUS DOGS ACT – ADVICE TO OWNERS**

The Dangerous Dogs Act was amended under the Anti-Social Behaviour, Crime and Policing Act 2014 which came into effect in England & Wales in October 2014. The amendments to the Dangerous Dogs Act 1991 came in to force in May 2014. This law applies to all dog owners.

Part 7 of the Act amends the Dangerous Dogs Act by:-

- 1) Making it an offence for owning or being in charge of a dog that is dangerously out of control in a private place – including the home and front and back gardens to the home. The previous legislation already covered public places.

There is an exemption in cases where a dog becomes dangerously out of control when a trespasser is inside, or is in the process of entering, a building that is a place where a person lives. It does not matter whether the person actually was a trespasser; if the owner is in the building when the dog becomes out of control and believes that the person is a trespasser that is sufficient. "Trespasser" takes its common law meaning, as someone trespassing against the occupier of the land. Whether a building is a "dwelling" is a question of fact that will be determined by the court in each case.

- 2) Empowering the Police or an appointed local authority to seize a dangerously out of control dog in a private place. The previous legislation already covered public places.

- 3) Providing that a dog attack (or reasonable apprehension that this may occur) on any assistance dog constituted an aggravated offence.
- 4) Ensuring that the courts can take account of the character of the owner of the dog, as well as of the dog, when assessing whether a dog should be destroyed on the grounds that it is a risk to the public.

## **What should dog owners be doing?**

**Ensure your gardens are safe.** The most important point to consider is how to keep unexpected visitors or delivery drivers safe on your property. Numerous Royal Mail and other delivery services employees are injured by dog bites each year and up until now there has not been the legislation to enable action to be taken to ensure their future safety. You need to make sure that any visitor can safely access your front door without encountering your dog.

There is a slight grey area in these changes in that if the person attacked is a burglar or trespasser your dog may not be considered dangerously out of control if it is in a building that is your private dwelling at the time of the attack. However, this does not cover incidents in your back or front garden so while the law is yet to be tested, all dog owners should ensure that all areas of their gardens where their dogs could encounter unexpected visitors are secure. It is worth talking to neighbours to ensure that children do not climb your fence to retrieve balls etc. to be on the safe side.

**Manage your dog when someone knocks.** Fewer letters are sent through the post, but the rise in internet shopping means that more parcels are being delivered. This change in legislation should be a wakeup call to all dog owners to ensure their dogs are under control when opening the door otherwise they risk committing a criminal offence. The easiest thing to do is to shut your dog in another room or in the garden. You also need to consider how your dog greets people. What you view as a dog being friendly by jumping up at visitors may be seen as threatening behaviour by a stranger.

**Owning a dog is a huge responsibility and should not be taken lightly, however by taking some time to think about what these changes mean to you and your dog, you will be taking steps to keep everyone safe and avoid ending up in a position that no one wants to find themselves in.**
